TERMS AND CONDITIONS

GKD HOLIDAY CAMPS

1. REGISTRATION AND PAYMENT

- 1.1. By registering for the holiday camps, students and legal guardians agree to abide by the general terms and conditions of Gymnasium & Internat Kloster Disentis (hereafter GKD).
- 1.2. Full payment must be paid by bank transfer no later than 14 days after registration. Registration is only finalized once the course fees have been received.
- 1.3. A written confirmation will be issued upon receipt of the full payment. With the confirmation and the receipt of your deposit, participation is guaranteed.
- 1.4. Required documents for camp acceptance are: Valid passport or identity card.

2. CANCELLATION AND REFUNDS

- 2.1. Participation on the holiday camps can be cancelled at any time and must be communicated in advance to GKD in writing.
- 2.2. Cancellations made 61 days or more prior to the start of the camps will be eligible for a partial refund of 75% of the basic fee.
- 2.3. Cancellations made 60 to 31 days prior to the start of the camps will be eligible for a partial refund of 50% of the basic fee.
- 2.4. For cancellations made less than 30 days prior to the start of the camps, no refund will be given.
- 2.5. For non-appearance, no refund will be given.
- 2.6. Refunds for cancellations resulting from force majeure events, including illness and accidents, will not be granted.
- 2.7. Students and legal guardians are responsible for covering any bank transfer charges incurred due to the refund process.

3. HEALTH AND MEDICAL

- 3.1. Students are required to provide accurate medical and health information during registration.
- 3.2. Participants are responsible for ensuring that they meet all Swiss applicable vaccination and entry requirements based on their country of origin and travel itinerary.
- 3.3. Students with pre-existing medical conditions or dietary requirements have to inform GKD at least 30 days in advance.
- 3.4. GKD reserves the right to seek medical attention for students in case of emergencies and to administer necessary medications. Doctors and health institutions are explicitly released from medical confidentiality.

4. SPECIAL DIETARY REQUIREMENTS

- 4.1 The camp provides standard European-style meals, including meat-based and vegetarian options. We are able to accommodate medically diagnosed food allergies and intolerances, such as lactose intolerance or coeliac disease, within reasonable limits.
- 4.2 We are unable to accommodate special dietary requirements based on personal, ethical, cultural, religious or other beliefs, including vegan, paleo, halal or kosher diets, or other individually chosen dietary regimes.

5. CODE OF CONDUCT

- 5.1. Students are expected to behave in a respectful and responsible manner towards fellow students, staff, other people's property and the facilities.
- 5.2. Bullying, harassment, or disruptive behaviour will not be tolerated and may result in immediate expulsion from the camps without a refund.
- 5.3. Consumption, possession and trafficking of alcohol or drugs will not be tolerated and may result in immediate expulsion from the camps without a refund.
- 5.4. Students are not permitted to keep any pets at school.



6. LIABILITY

6.1 GKD guarantees expert class instruction based on an institutional teaching plan together with a meaningful boarding experience within the limits of a holiday program.

6.2 Within the scope of due diligence, Gymnasium & Internat Kloster Disentis is liable for the content of the promised services. Liability is limited to the amount of the camp price.

6.3 GKD is not responsible for any loss, theft, damage, or injury to personal property or persons during the stay.

6.4 Students and legal guardians release GKD and staff from any liability related to accidents, injuries, or illnesses that may occur during the stay.

7. INSURANCE

7.1 Students are obliged to take out health and accident insurance as well as liability insurance during their stay in the camps. It is the responsibility of each student to ensure they have adequate insurance coverage for the duration of their time on the camp.

7.2 Upon departure, students are responsible for taking all their belongings with them or for making any necessary shipping arrangements. The school is not responsible for any items left behind.

7.3. Students should not bring any valuable items or large sums of money to the camp (however, if necessary, such items may be deposited with the school for safekeeping).

8. CHANGES AND CANCELLATIONS BY THE CAMPS

8.1 GKD reserves the right to modify the camp schedule or activities due to unforeseen circumstances.

8.2 Should unforeseen circumstances lead to the cancellation of the camps by GKD, students will receive a complete refund of the paid amount. However, GKD cannot be held responsible for any incurred losses or indirect expenses related to program bookings, such as travel, accommodations, visa fees, or bank transfer charges.

9. IMMIGRATION REGULATIONS

9.1 It is the responsibility of students and legal guardians to ensure the legal entry of students into Switzerland.

9.2 Students and legal guardians are obliged to adhere to immigration regulations.

10. CONTRACTUAL COMMITMENTS AND SAFETY ACKNOWLEDGMENTS

10.1 Upon signing the application form, legal guardians acknowledge the program description, admission conditions, and school and boarding rules as integral components of the contractual agreement.

10.2 Dispensations from lessons or leisure activities are not possible except for medical reasons.

10.3 Legal guardians confirm their awareness that the participant will engage in sports activities entailing inherent risks, such as skiing, snowboarding, biking, water sports, adventure activities, and the like.

10.4 The GKD is authorised to collect personal data (in particular contact details) as well as photographs or videos during the camp and to use them for marketing and opinion surveys, as well as for its own advertising and marketing purposes.

10.5 GKD is authorised to process special categories of personal data, insofar as such data is necessary for the fulfilment of the contractually agreed services (e.g. the provision of certain meals). This data mainly comprises health-related data.

11. GOVERNING LAW AND JURISDICTION

11.1 These terms and conditions shall be governed by and construed in accordance with Swiss Laws.

11.2 Place of jurisdiction is Chur.
